2019 PSACF Homemade Chocolate Cake Baking Contest

RULES:

- Participant must be an individual amateur baker who is a Pennsylvania resident. **One entry per person.**
- Entrants may NOT have won 1st place in this Homemade Chocolate Cake contest at any other fair in 2019.**
- Entry must be a layered chocolate cake made from "scratch." Pre-made mixes are not acceptable ingredients.
- Entry must be frosted and frosting must be made from "scratch."
- Cake recipe must feature chocolate or cocoa as a main ingredient.
- The entire cake entry must be submitted for judging on cardboard or other food safe disposable setting. (All pans, plates and dishes are considered to be disposable and will **not** be returned.)
- Recipe must be submitted with the entry, printed on one side of 8 -1/2"x11" paper. Recipe must list all ingredients, quantities, and the preparation instructions. Entrant's name, address and phone number must be printed on the **back** side of all the pages. (All recipes and pies will become the property of the Fair or PA Farm Show and will **not** be returned.)
- Refrigeration is **not** available at the Fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.

2019 PSACF Junior Baking Contest - Cookies, Brownies and Bars

RULES:

- Participant must be an individual amateur baker (age 8 through & including 18 years old) who is a Pennsylvania resident. **One entry per person.**
- Entrants may not have won 1st place in this PA Preferred Junior Cookies, Brownie or Bar contest at any other fair in 2019.**
- Entry must be a plate of size (6) individual sized portions of the baked entry items.
- Entries must be made from scratch. Pre-made mixes are **not** acceptable ingredients.
- At least two (2) PA Preferred ingredients must be used in the recipe. Some examples of qualifying ingredients are PA Preferred grains such as oats or flour, butter, milk, eggs, fruits and/or vegetables.
- Entry must be submitted for judging on a food safe disposable setting. (All pans, plates and dishes are considered to be disposable and will **not** be returned.)
- Recipe(s) must be submitted with the entry, printed on one side of 8 -1/2" x 11" paper. Recipe must list all ingredients, quantities, and the preparation instructions. PA Preferred ingredients must be listed clearly in the ingredient list, specifying the ingredient and the company that made/grew them (ex: PA Preferred Milk - Galliker's brand). Entrant's name, age, address and phone number must be printed on the **back** side of all the pages. (All recipes and cookies, brownies or bars will become the property of the Fair or PA Farm Show and will **not** be returned.)
- The PA Preferred logo is not required because not all PA Preferred products carry the label. The name of the ingredient and the source is sufficient. For a list of acceptable products visit papreferred.com. Additionally, PA Preferred staff will assist in locating PA Preferred ingredients, as needed.
- Refrigeration is **not** available at the Fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.

Angel Food Cake Contest Rules

- Open to any individual who is a Pennsylvania resident.
- Entrants may NOT have won 1st place this Angel Food Cake contest at any other fair in 2019.**
- Entry must be an Angel Food Cake made from "scratch".
- Pennsylvania produced & packed eggs** are requested to be if at all possible. Please look for the PEQAP or PA Preferred logo or PA packaging dates on the carton.
- Refrigeration is **NOT** available at the fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after the judging for food safety reasons.
- Cake entry must be submitted for judging on cardboard. (All pans, plates and dishes are considered to be disposable and will **not** be returned.)
- Recipe(s) listing the ingredients and the preparation instructions must be submitted with the entry (*printed on one side of 8 1/2" x 11" size paper.*) Entrant's name, address and phone number must be printed on the back of the page. (All recipes and pies will become the property of the Fair or PA Farm Show and will **not** be returned.)
- Judging will be based on the following criteria:



Flavor (smell, taste, flavoring)	30 points	Prizes: 1st - \$50 2nd - \$30 3rd - \$20
Inside Characteristics (texture and lightness)	25 points	
Overall Appearance (surface, size, color)	20 points	First place winner is eligible for 2020 PA Farm Show Competition.
Creativity	15 points	Prizes for PA State Angel Food Cake Winners:
Topping, Icing or Decoration	10 points	1st - \$500 2nd - \$250 3rd - \$100
